<u>Operations Committee</u>- A workday was held on October 26, and at least 50% of the creek brush was cleared out. There was also a lot of cleanup done inside the clubhouse.

The light in the back has been fixed.

Rules Committee- No report given.

Old Business-

a. The park has been repaved, but a pillar was hit by a loader so the payment to Luke's Asphalt is being withheld until that has been fixed. An email will be sent to them giving them until the

end of November to send someone to fix it. Otherwise, we will hire someone and reduce the amount due Luke's by that amount.

The septic tank has also been pumped.

b. The Rental Agreement has been revised to include the bouncy house verbiage that was previously voted on, and this document has been notarized, but still needs to be filed with the county.

New Business -

- a. The GVTC Telephone bill will be presented in January, to determine if we can get better service elsewhere.
- b. The gate system has been updated and is in the process of being completely cleaned up.
- c. Dues can be increased effective 2026, based on the CPI.
- d. Bob suggested creating a new event to be held at the park. We will discuss having Farmer's Markets/Craft Fairs next year, where only members of the community can participate.
